- Amount of money due.
- Date when payment must be received.
- If payment is not received by the due date, a 10% penalty will be due.
- Amount of previous bill and previous bill date.
- Water bills are based on two charges: a base charge and a volume charge. The base charge is a flat fee (\$4.50 in this example).
- The volume charge is calculated based on the actual amount of water used during the billing period. In this example, 5,000 gallons of water was consumed during this billing period (5 x 1,000 gallons). To calculate the volume charge, multiply the consumption amount x the published volume charge in our rate tables. In this example, the volume charge based on our current rate tables is \$13.75 (5.00 x \$2.75).
- Sewer bills are based on two charges: a base charge and a volume charge. The base charge is a flat fee (\$6.00 in this example).
- The volume charge for sewer is also calculated based on the published volume charge in our rate table. In this example, the volume charge based on our current rate tables is \$15.25 (5.00 x \$3.05).
- The Water Authority does not have taxing authority. This tax is levied by the City of Roanoke or Roanoke County.
- Average cost of water and sewer service per day.
- "E" indicated that this bill was based on an estimate. Utility bills are either based on an actual reading or an estimate based on the previous actual readings. If any settle-ups are due, they will be reflected on the next month's bill based on the actual meter reading.
